A review of our records indicates that the Massachusetts sales/use tax exemption for **NEW DEMOCRACY**, **INCORPORATED**, a tax-exempt 501(c) (3) organization, will expire on **05/18/08**.

The Department of Revenue is issuing this notice in lieu of a new Form St-2, "Certificate of Exemption".
