Dear Taxpayer,

A review of our records indicates that the Massachusetts sales/use tax exemption for **NEW DEMOCRACY, INCORPORATED**, a tax-exempt 501(c) (3) organization, will expire on **05/18/08**.

The Department of Revenue is issuing this notice in lieu of a new Form St-2, "Certificate of Exemption". The notice verifies that the Massachusetts Department of Revenue has renewed the sales/use tax exemption for **NEW DEMOCRACY, INCORPORATED** subject to the conditions stated in Massachusetts General Laws, Chapter 64H, sections 6(d) or (e), as applicable.

*The organization remains responsible for maintaining its exempt status and for reporting any loss or change of its status to the Department of Revenue. Absent the Department of Revenue's receipt of information from the taxpayer by the expiration date of the current certificate that the entity no longer holds exempt status under the above provisions, the taxpayer's certificate is renewed. **This renewal will expire on 05/18/18.***
